I met Honey years ago, when we were selling Shop Rite and Price Chopper cards to raise money to build our new rectory and Little Lambs. I had the privilege of working beside her and Helene Shepard, our now National Regent, and they spent a lot of the time we were together trying to recruit this then young mom to join. I resisted as long as I could with the (valid) excuse that I had children who were active and in school and had no time for CDA. But, eventually, those kids grew up and I had no more excuses.

My most vivid memories of my installation as a Catholic Daughter were of Honey (then Regent) telling everyone how she always wanted to be a Catholic Daughter because she wanted a lot of people at her funeral. That wish was granted this week, along with her desire to be buried in her robe. (For one of her birthdays, "the posse" bought her her own robe.) And all along she never wavered in her love of or devotion to CDA—always an active participating member to the end.

Next month I will be attending the National Convention in South Dakota along with, literally, hundreds of Honeys—strong, devoted, active women doing a lot of good for our organization, our Church and our world. I can't even begin to imagine aspiring to the level of some of these wonderful women and look forward to learning from and sharing with them all.

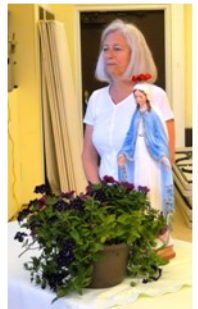
