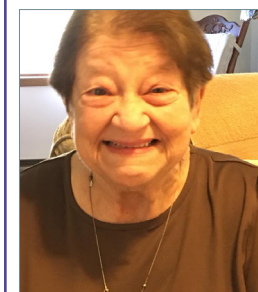
**Second Vice State Regent Connie Breindel** stepped right in and has reformatted and relaunched our website (thanks Connie!). (Due to be live by 11/25)

## Lighting the Fire

Isn't there something magical about sitting around a bon fire? Roasting marshmallows, telling stories, laughing, singing—there's nothing like it.

This year, my husband Hector upgraded our backyard firepit with new stone, a pebbled surface area and cushioned benches, it is beautiful! Partly due to quarantine, we spent many nights out there this spring, summer and fall.

As I think back now to those wonderful nights, either alone, with the kids or with friends, I think of a fire as a comparison to our courts. I found some of these tips on a website about planning the perfect campfire. **A proper fire does many things: it warms your body, cooks your food, and lights up the darkness. Unfortunately, you can't have any of those if your fire extinguishes itself in 5 minutes. Learning how to build a great fire is a valuable skill that you can use for life**—and a lesson on building the fire of our courts so we can live our State Regent's theme to Let Your Light Shine.

**Before you even light a match, you have to prepare your site for a campfire properly, cleared of weeds and leaves and ready for you to place your stones.** We have to make sure that our community, parish and pastor are ready to receive us, host us and support us. This might mean that you need to meet with the pastor or members of your parish council to ensure that you have a proper meeting space that fits your needs and the support of others in the area.

**It's impossible to build a great campfire without a good handful of tinder, small twigs, paper, cardboard. You can't just take a match to a giant log and expect it to light. Instead, start with tinder. Tinder catches fire fast, but it also burns fast.** We need those members who catch the spark right away and burn hot with the desire. Sometimes these tinder members have new ideas, don't squealch them; sometimes they want to take on office, don't dissuade them by saying they haven't been a member long enough. We need tinder to get things going, but we can't just light them and leave them...they will burn out too quickly!

**Once your tinder is rolling, it's time to scale into some slightly larger wood. You can't go from tinder to large fuelwood immediately—that will just smother your little fire.** Ok, so, we know, sometimes, when you've got those

tinder members, hot with the fire, the fuelwood members (one's that have been around forever and chaired every committee and held every office at some time over the years) if thrown right on top of the tinder, they can smother them. We need to support the tinder, not drown it.

**That's where kindling comes in. Its role is to help shape the fire.** The kindling is the committee, the members that want to help and support the tinder, to make them successful in encouraging the fire and keeping it burning hot and bright. They don't smother the tinder, they don't dismiss their ideas, they don't say "we've tried that before," they don't say "that will never work here." They pitch in, they try to encourage the flames grow, they help the fire keep burning.

**Finally, we have the fuelwood. This is any type of heavy wood that will keep your fire going for an extended period. It's the primary fuel for your fire.** You remember them, the members that have been there through thick and thin, the members that have dedicated themselves to your court and the Mission of CDA over the years? We need that fuelwood (though I wasn't a fan of the article I cite using the word heavy! LOL), we rely on the skill and experience of our long-term members to lead, to bolster, to support all of our efforts; to keep our fire burning long and strong and hot so that we may be that light in the darkness, that warmth when it is needed.

Now it's the time to keep adding fuel to the fire to maintain it. What about if no one has been tending to the fire for a while, no one has been stoking the flames, no one has been adding wood? Well, the fire will simply burn out. So what do we do then? We sweep up the ash and start anew!

**You got your fire going? Awesome.**

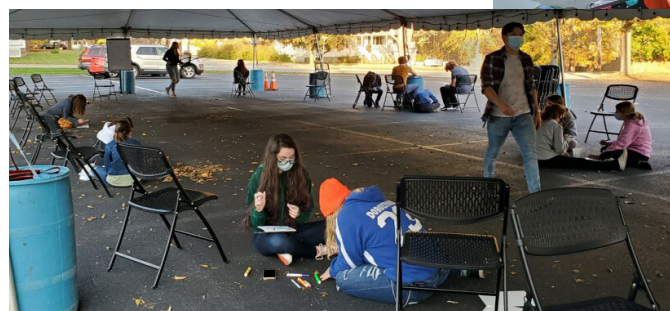

And always did the love show through.

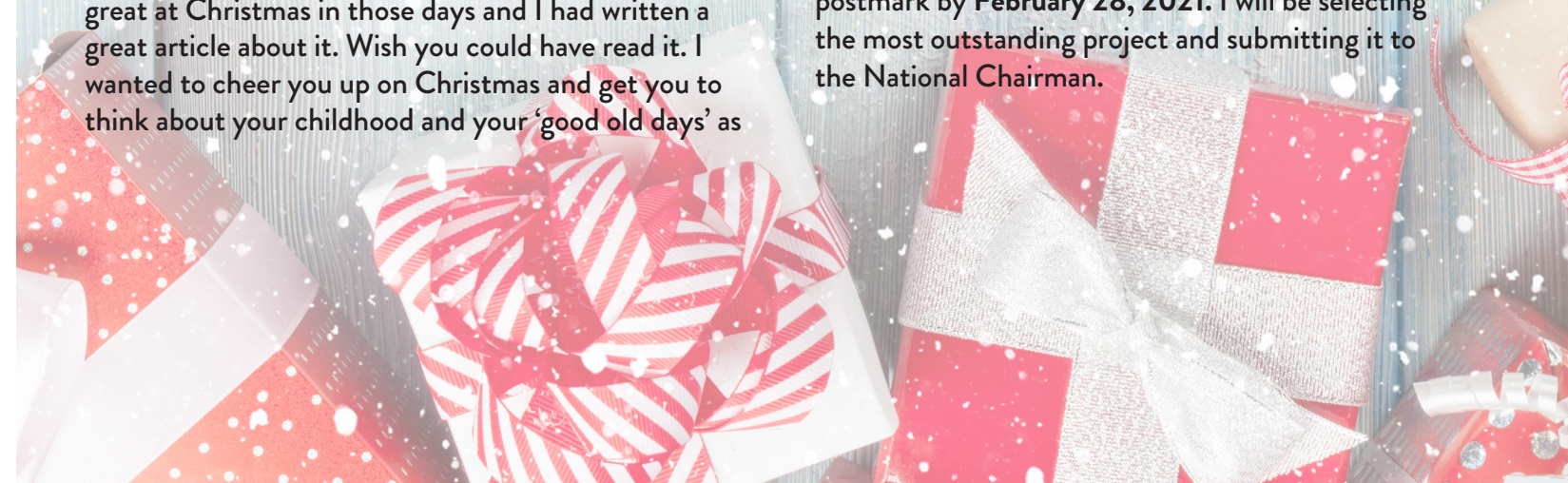
Then dad would set the trains around

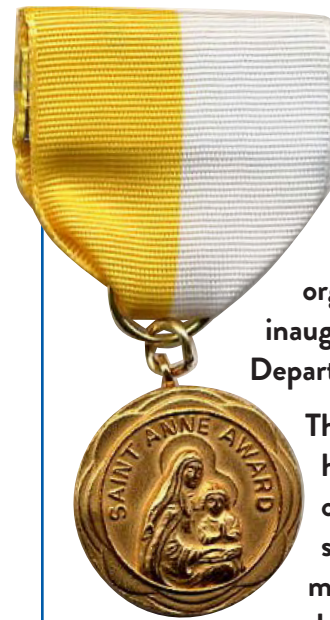
